The following were present for part or all of the meeting: Charles J. Smith (Chair), Susan J. MacKenzie (member) and Matt Brown

1. Meeting was called to order at $4: 00 \mathrm{pm}$ by Chair Smith.
2. Matt Brown notified the board that Hand and heart Productions would not be doing an event on Scott Bailey's field and he had already told Scott to plant it in corn. The Board gave Matt a list of conditions which addressed the concerns of the Board, the Police Chief and the Fire Chief. We discussed some of the items and concerns.

11. Discussed Cutting Ln. MacKenzie had talked to Fred and also had an engineer look at the situation with the road washing out. There are several possible solutions and she will outline them in a letter to the landowner so the landowner can decide what she would like to have
done.
12. Discussed complaints of excessive speed by cars using Shoestrap Rd as a shortcut in the morning. Chief O'Keefe has been apprised of the situation.
13. At $5: 15$ pm Smith motioned and MacKenzie seconded to enter into non-public session under RSA 91-A: 3 II c. Reputation. Present were Smith and MacKenzie.
