- 1. Chair Smith called the Selectboard meeting to order at 8:00AM
- 2. Library: Library Trustees reviewed the proposed 2014 budget-Russell review various lines of the proposed 2014 budget. The following topics were discussed:
  - Wage increases
  - Renovations to the Children's area
  - Change in Custodial services
  - Friends of the Library support up to \$3,000.00 in programing
  - Some not for profit groups use the down stairs room for no fee
- 3. Pathways Engineering: Mr. Williams and Mr. Finley reviewed various concerns on River road south. Highlights from Field work; Field observations, wetland & Invasive Screening, Topographic survey, geotechnical investigation. Pathways reviewed existing conditions, conceptual design recommendations & draft plans and draft probable costs. The next step is to think about and discuss to alternatives for this section of River Road. Smith will be submitting an application for a grant using these draft figures and information.

  - Waterbury, Jonathan-Map 415 Lot 27-Smith Mountain Road

- The Selectboard will hold a 2014 proposed budget workshop on Tuesday October 29<sup>th</sup>, 2013 at 9:00AM in the Town Offices. Cutting will send spreadsheets with proposed budget figures and Capital Reserve Fund projections out prior to the weekend for review.
