Per RSA 231:184 and 131:161 you are required to have the Select Board grant you permission to install a conduit to run fiber, wire or cable under_____.

We understand that you have met with the Road Agent, Steven Williams concerning the installation of conduit under the listed road and location.

Town road _____, for the property at _____.

The following conditions must be met:

- Notify the road Agent before you begin the excavation on any permit.
- The conduit will be installed according to best practice methods.
- The conduit must be buried below the frost line (at least 3') in depth unless ledge/rock prevents that depth, any conduit that is less than 3' will be incased in concrete.
- Where conduit must cross the road, it will be bored under the road if paved and bored under gravel roads where possible. If a road cut is required, you will notify the Road Agent prior to doing this work.
- Marking tape and tracer wire will be placed to allow the location of the duct to be determined.
- You will insure the road is restored to the condition it was previous to your installation of this conduit.
- If you have to excavate the roadway, you are required to contact and coordinate with the Lyme Police Department for traffic control.
- The Road Agent, Steven Williams will check this project when the work is completed. To finalize the Road Agent will sign the permit document once inspection has been completed and the Road Agent determines it is done to his satisfaction.
