

## RECREATION FACILITY MONITOR

Responsible for ensuring all facility users are Lyme residents.

Monitor people and vehicles entering Chase Beach/Recreation area

Advise those who are not Lyme residents that this is not a public area

If a non-resident advises that they are a guest with a Lyme resident, ensure from your list that the Lyme resident is actually present with the guest. If the Lyme resident is not at the area, then the guest must leave.

Responsible for monitoring the entrance.

Document all vehicles entering (write down name and plate numbers) (this information goes to the Police department only)

Responsible for filling out a daily log.

This position will work closely with the Police department and communicate information on a scheduled base.

This position will report to the Town Administrator.

### POSITION REQUIREMENTS:

1. Knowledge of and the ability to enforce all policies, procedures and regulations set by the Select Board and Recreation Commission for use of the Recreation Facilities.
2. Have the ability to positively communicate in a sometimes-stressful situation.
3. Professional presentation and positive role model in the execution of duties, at all times.
4. Able to work outdoors and in adverse weather conditions such as extreme heat; precipitation; etc.

This is a temporary Part-time seasonal position with no benefits - hourly rate \$15.00 (15 to 32 hours per week for 9 - 12 weeks)

**Section 1.1: General Regulations:** The following regulations apply to the recreation facility at Post Pond including Chase Beach and surrounding Playground areas, the John Balch Memorial Field, the Arnie Pushee Basketball Court and the Tennis Courts but do not apply to the boat launch facility (which is covered by a separate document).

Recreation areas are for the use of Lyme residents and their guests. (Lyme resident must be at the location with the guest)

All recreation areas will be closed from dusk to dawn (with the exception of authorized events)

All motor vehicles shall be parked in the parking lot and are not allowed in the beach or field areas. Town of Lyme Resident stickers are required in the parking area.

No alcoholic beverages are allowed at the beach, on the courts or on the playing field. Persons carrying alcoholic beverages into these areas will be asked/required to leave and may be prosecuted for violation of this ordinance.

All domestic animals (with the exception of service animals) are to be kept on the road or in the parking lot and not at any time allowed in the Chase Beach, Memorial Field, basketball court, and/or tennis court areas.

No camping and/or overnight activities are permitted.

All litter and trash is the responsibility of the user. Lyme Recreation Facility is carry in – carry out.

Vendors or peddlers are not allowed without prior written permission of the Recreation Commission. No personal financial gain selling of products or services shall occur at this facility.

No fires of any kind are allowed except in a raised barbecue grill.

**Section 2.1: Chase Beach Regulations:** All persons in the Chase Beach area or in the designated swimming area shall at all times follow the posted regulations:

All children 12 years of age and younger must be accompanied by an adult at all times.

No boat of any kind is permitted within 25 feet of the swimming area. Boats may not come ashore onto or be launched from Chase Beach. (This includes paddle boards and blow-up boats)

No person may fish from within 25' of the beach area at any time.

No swimming in disposable diapers and no swimming in bare bottoms.
