

FEE SCHEDULE

Fee Payment Cards or Stickers may be purchased at the **Town Clerk's Office** (M, W, F, 8:00am-2:00pm), **Lyme Home & Hardware** and the **Lyme Country Store**:

\$20- Trash Bag Stickers (5 per sheet)

30 lb. Weight Limit on Bags.

BULKY ITEMS:

The Transfer Station does not accept these items.

Bulky items include:

- Couches, Recliners, Futons, ect
- Mattresses, Box Springs
- Anything that would not typically go into your trash.

If you have any bulky items like this please bring them to the **Lebanon Landfill**.

CONSTRUCTION MATERIALS:

The Transfer Station cannot accept any materials that go into the construction of a home. These items include:

- Lumber of any type
- Roof shingles
- Bricks or Concrete
- Cabinets

These items can be taken to **Hammond Grinding and Recycling** in Canaan, NH, **Casella Waste** (40 N Labombard Rd, Lebanon, NH 03766) and the **Lebanon Landfill**.

TIRES:

Lyme Transfer Station does not Accept Tires. Tires can go to the **Lebanon Landfill**.

REFRIGERATORS/FREON ITEMS:

AC's, Dehumidifiers, Refrigerators, can go to **Lebanon Landfill or Evergreen in Wilder**.

SAFETY

Safety is the primary concern at the Transfer Station. Please be extremely alert to potential hazards while driving into the transfer station. Please adhere to these safety rules:

1. **Stop at the red stop sign**
 2. **Put your vehicle in park**
 3. **Wait until the person at the trash compactor is finished unloading and has entered their vehicle**
 4. **Pull forward to unload trash**
 5. **Keep vehicle in park until car in front has finished unloading recyclables and has entered their vehicle**
 6. **Pull forward to unload recyclables**
- No person shall be allowed to remove items from the metal bin.
 - Watch for pedestrians when operating your vehicle
 - **No Dogs Allowed outside of a vehicle at the Transfer Station!**
 - **No children should be allowed outside the vehicle at the Transfer Station. If they cannot drive, they should not be out of the car. There are too many hazards.**

Please alert the attendants of any safety hazards you encounter.

Incident weather regulations and closure of the Transfer station:

- ✓ The Transfer Station may be closed when the temperature is below 0.
- ✓ The Transfer Station may be closed during snow and ice storms.
- ✓ The Transfer Station WILL be closed during all electrical storms.
- ✓ **Any closing will be posted on List-Serv and at the Station**

TRASH & RECYCLING

The pay-as-you-throw and Recycling program provides a simple, fair and easy method for disposing of household trash and recyclable items. **You must be a Lyme Resident to use the Transfer Station. Make sure you have an updated resident sticker in your window or you may be turned away!**

Here's how it works:

Household trash: must be in trash bags, tied shut or in a closed commercial bag.

Neither bag may weigh over 30 pounds. Commercial bags require the use of a Green Payment Sticker.

Zero-Sort Recycling: must be in an open top bin. Do not bag your recycling. If you do this it will be disposed of as household trash. Please visit this link for details about what *WHAT BELONGS* in your recycling and *WHAT DOES NOT BELONG* in your bin:

Bulky items and C+D Material: These are all items that would not typically be put into your trash bags. Please bring these items to the **Lebanon Landfill**. They are open Mon-Fri 8:30-5:00 P.M. and Sat 8:30-2:00

Fluorescent Bulbs and Mercury:

We accept fluorescent bulbs and mercury devices at the transfer station for FREE! Please ask an attendant if you are unsure about your items.

Batteries:

We accept batteries at the Transfer Station for FREE. Please ask an attendant. **Lithium batteries are especially dangerous and can cause fire. Please use caution with them and do not throw them in your trash.**



Scrap Metal Recycling: We encourage residents to put your empty tin and aluminum cans into the scrap metal bin. In this bin we get revenue and it gets recycled in the same manner as Zero-Sort. Otherwise we pay to have it recycled in Zero-Sort. Please check in with an attendant before putting any questionable scrap metal items into the bin.

Used Motor Oil: Motor oil can be brought to local automotive shop that accept waste oil for fuel. Automotive stores will accept and oil change worth of oil as well.

Hazardous Household Waste: oil based paint, gasoline, insecticides, asbestos, automobile batteries, tanks, any flammable, caustic or toxic substances and unwanted medicines **cannot** be disposed of at the Lyme Transfer Station. Household Hazardous Waste collection days are held periodically through the Upper Valley Hazardous Waste organization. [Household Hazardous Waste - UVLSRPC](#)

Free Area: Another way to try and reuse items instead of throwing them “away”. Please leave only useable smaller items in this area. It is located inside the fenced area near the metal bin. **Absolutely no Hazardous materials can be left in the Free area at any time, useable or not. This includes pesticides of any type, oil based paints, flammable liquids, ect...** The transfer station is NOT permitted to accept these items at any point.

Electronics: collection day is held at the Lyme Transfer station once yearly. A fee will be paid to an outside vendor. If you miss the collection event there are 2 options. 1. Evergreen Recycling in Wilder, VT. 2. Lebanon Landfill.

When in doubt, ask the attendant!
