**Article 01 To hear the reports of others**

To hear the reports of Agents, Auditors, Committees, or other officers heretofore chosen, and pass any vote relating thereto.

**Article 02 Operating Budget**

To see if the Lyme School District will vote to raise and appropriate \$9,857,431 for the support of schools, for the payment of salaries for the school district officials and agents, and for the payment for the statutory obligations of the district. This article does not include appropriations contained in any special or individual articles addressed separately, except for the amounts in Article 4. Majority Vote Required. The School Board recommends this appropriation (6-0). The Budget Committee recommends this appropriation ().

**Article 03 Use of Bond Proceeds**

To see if the District will vote to authorize the expenditure of the unused portion of the bond approved in 2024 for improvements to the Lyme School and to raise and appropriate the aggregate amount of \$241,643: unused bond proceeds (\$126,888) and interest (\$114,755 as of 1/13/2026, or the amount accrued at the time the account is closed) for the following purposes pursuant to RSA 33:3-a, II:

1. Replace outdated univents in 1994 wing of the building
2. Upgrade and refresh 1st and 2nd floor student bathrooms in the 1994 wing of the building and
3. Renovate the science room in the 1994 wing of the building.

Any unused portion of the aggregate amount will be used to pay the bond payment. No amount of money to be raised by taxation. (2/3 ballot vote required). The School Board recommends this appropriation (6-0). The Budget Committee recommends this appropriation ().

**Article 04 Salaries of District Officials**

To determine and fix the salaries of school district officers as follows: School District Treasurer \$825; School District Clerk \$100; School District Moderator \$100. The amounts in this article are included in Article 2. The School Board recommends this appropriation (6-0). The Budget Committee recommends this appropriation ().

**Article 05 Other business**

To transact any other business that may legally come before this meeting.
